1. Quotationers have to submit attested copies of VAT clearance certificate from the Sales Tax Authority of the State of Jharkhand or any other state as applicable.
2. Quotationers should quote their rates item wise unit wise against the schedule both in figures and in words. The rate should be inclusive of S.T., surcharge and all other taxes and duties. No additional payment will be made to the successful quotationer beyond the offered value.
3. Tender Specific Authorization from the Principal Company is a must for all Participating vendors mentioning details like tender number, date and products for which the authorization is provided and the same should be enclosed in originals. The authorization from the Principal Company should be addressed to The Director, Jharkhand Space Application Center
4. Time of completion of the work is 30 (Thirty) days from the date of issue of work order.
5. Acceptance of lowest rate is not obligatory and the undersigned reserves the right to reject any or all quotations without assigning any reason thereto.
6. Installation of the above should be done without creating any significant disturbance to office environment and existing computer network (LAN). Before submitting quotations, quotationers may inspect all the existing installations to take necessary precaution for the installation of above-mentioned work.
7. Bidder must mention minimum system specification for the solution required.
8. Any discount /free modules /free services (if any) should be mentioned in the quotation.
9. Quotations in sealed cover mentioning the work name must reach this office on or before scheduled date and time. Willing quotationers or their representatives may attend opening of the quotations.
10. Quotationers may be barred from submitting quotation for a period of six months if they fail to complete the work within the stipulated time.
11. After satisfactory completion of the work, the agency will have to submit the challan/bill in triplicate with copy of Supply Order to this office and payment will be made by Jharkhand Space Application Center after passing of bill from this end.
12. The Earnest money deposit shall be Rs 1, 00,000 submitted with the Technical Bid in shape of Bank Draft issued by any Nationalized Bank having branch at Ranchi. The Bank Draft should be in favour of Jharkhand Space Applications Center, Ranchi.
13. 100% payment will be made after successful supply, Installation and training.
14. The performance security will be 10% of the value of contract in the form of Bank Guarantee.
