

Minutes of the Pre-bid meeting of "Survey Of Government Health Facilities Using GPS Under Jharkhand Rural Health Mission Society (JRHMS)" held on 24th March 2014 at 3:30 pm at the Chamber of Director, Jharkhand Space Applications Center, Ranchi.

The following clarifications were given in the meeting on the tender document;

1. Representative from M/s Geoinfosys Technologies requested to give relaxation from qualification criteria (Page No. 2, Point 2) which states that "The Company should enroll under company act 1956". The committee decided that there will be no change in qualification criteria.
2. Representative from M/s Metric Consultancy Ltd. inquired about the criteria of experience in survey and data entry. It is being clarified that experience will be considered as it has been written in the tender document.
3. A representative from M/s Whiz Mantra questioned that data entry will be done online or offline? It is being clarified that it will be done offline only.
4. A representative from M/s Cyber Swift requested to exempt their company from submission of EMD as their company falls under category of small scale industry. The committee instructed to submit

the relevant paper to JSAC which exempt their company from submission of EMD.

5. Representative from M/s Cyber Swift inquired about the mode of submission of tender. It is being clarified that the mode of tender submission will be online through following website:

6. Representative from M/s RAMTeCH inquired about the mode of payment of EMD of Rs. 5 Lakhs. It is being clarified that the mode of payment of EMD and tender fee will be online.
7. Representative from M/s Cyber Swift inquired about who will verify and approve the survey data. It is being clarified that as it has been written in the tender document the survey data will be verify and approved by the Head of the concerned health center. The survey data should also be stamped by the Head of the concerned health center.
8. All the vendors raised the question about the survey of private hospitals. The committee clarified that only government recognized private hospitals will be consider for survey as mentioned in tender document (Page No. 34).

Lastly, Director, JSAC told that company should read the tender document carefully and accordingly fill the e-Tender. The meeting ended with vote of thanks by the chair.
